Benefits Update

Benefits Open Enrollment occurs October 7 – 18, 2024. The [Open Enrollment website](#) is open, and this email details benefits changes that will take effect January 1, 2025, resources and tools you need to learn regarding your benefits, and what you can do to prepare.

This is a busy time of year, and your benefits are an important financial investment. Take advantage of all the benefits UVA offers you this year and be ready to choose when Open Enrollment opens in Workday.

Benefits Changes

Important changes you will want to understand

Benefits changes for plan year 2025 include the following:

- ***The UVA Health Plan option names will change to better reflect the differences in the plan options. All plan options offer the exact same services as before.*** The Choice Health option will be closed to new enrollees starting 1/1/2026.
 - Basic --> Health Savings – HDHP, includes Health Savings Account with employer contribution
 - Value --> UVA PPO – includes flat copays for some services, higher premium and lower deductible than Health Savings option
 - Choice Health --> Choice Health (closes to new enrollees starting 1/1/26) – highest premium, lowest deductible
- ***Health plan premiums will increase for the UVA Health Plan and J Visa Health Plan.*** There are no changes to deductibles, coinsurance, or copays. As a self-insured health plan, the Plan is paid for by employee and employer contributions. While premium rates will increase in 2025 due to rising prices and employee utilization, the employer contribution will cover the greatest part of the increases.

- **Health Savings Account (HSA) employee + employer IRS contribution limit will increase.**
 - Maximum HSA employee + employer contribution will rise to \$4,300 for individuals and \$8,550 for families.
 - The “catch-up” contribution (for ages 55+) remains the same at \$1,000.
 - The employer seed funds of \$1,000 for individuals and \$1,500 for families will remain the same.
- **403(b) and 457 contribution limits will increase** (2025 rates not announced yet), and participants ages 60-63 can contribute an additional catch-up amount of \$10,000 or 150% of the annual 50+ catch-up amount, whichever is greater.
- **VRS retirement record-keeper will change.** The Commonwealth of Virginia is moving from MissionSquare to Voya to manage its Virginia Retirement System (VRS) defined contribution plans, beginning January 1, 2025.
- **New name, same benefits!** Virgin Pulse, the company that delivers the Hoos Well portal, is changing its name to Personify Health™. Hoos Well programming and the user experience will not change due to the rebranding.

Action Items

Prepare for Open Enrollment

1. **Familiarize yourself** with the Open Enrollment website.
2. **Redeem Hoos Well rewards** by November 30.
3. **Deplete Full FSA to \$0.00** if considering moving into Health Savings (Basic) for the first time.
4. **If you're adding a new dependent to your health plan**, have your dependent [required documentation](#) ready to upload into Workday during Open Enrollment. You will not be able to submit your benefits elections if you have added a new dependent to your health plan and have not provided the required documentation.

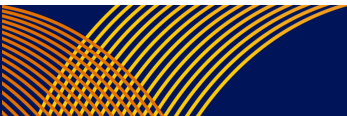
5. **Schedule a 1:1 appointment** with HR specialists if you need help. Call 434.243.3344 to schedule.
